## **TERMS & CONDITIONS**

1. The statements made by the Business Advisor/Executive (Agents) in answer to the questions in the Application Form (a copy of which is annexed) and the declaration made therein shall be the basis of the contract.
  2. The Business Advisor/Executive (Agents) shall comply with all the applicable statutory and regulatory provisions, regulations, etc.
  3. The Business Advisor/Executive(Agents) shall carry out such directions and instructions as may, from time to time, be issued by TCFS or persons duly authorised by TCFS for the purpose of fully and effectively carrying out the terms relating to the Business Advisor/Executive(Agents) here in. The Business Advisor/Executive(Agents) shall render the services herein with utmost care and diligence.
  4. The business Advisor/Executive(Agents) is not authorised to receive cash/cheques/DD on behalf of TCFS and issue any receipt there for. However, the Business Advisor/Executive (Agents) shall advise/assist the applicants to lodge their applications together with the relevant amounts with TCFS or designated branch of the Bank authorised to function as the Collecting Bank for receipt of application money and for issuing an official receipt there for.
  5. The Business Advisor/Executive (Agents) is eligible for commission on the business canvassed by the Business Advisor/Executive(Agents) at the rate/rates prescribed by TCFS. Provided, however, that the rates are subject to revision at the discretion of TCFS from time to time and the Business Advisor/Executive(Agents) shall be bound by such changes.

The Business Advisor/Executive (Agents) agrees that TCFS shall be entitled to recover or adjust all such amounts as are wrongly paid to the Business Advisor/Executive(Agents) from time to time and out of any commission or any other sum payable by TCFS to the Business Advisor/Executive(Agents) .
  7. The appointment of the Business Advisor/Executive (Agents) shall be liable to be terminated by TCFS forthwith:
    - a) if in course of any judicial proceeding it is found that the Business Advisor/Executive(Agents) has knowingly participated in, or connived at, any fraud, dishonesty or misrepresentation against TCFS of any client of TCFS;
    - b) if the Business Advisor/Executive (Agents) is found to canvass the business (issued under any scheme) in or around the premises of the office of TCFS with a view to intercepting a direct sale or act in any other manner prejudicial to TCFS .
    - c) if TCFS is satisfied that any statement made in the Application Form was false or misleading or calculated to mislead.
    - d) if the Business Advisor/Executive(Agents) acts in any other manner prejudicial to the interest of TCFS.
  8. The Business Advisor/Executive shall not use any unethical means to sell and market any product(s) under this arrangement.
